- Only Members and invited guests will be entitled to attend the meeting.

- Members who wish to ask a question may do so through the Q & A **chat function** available through Zoom. The Chair of the meeting will determine who among the Board is best suited to answer any question.

- Only one item, the immediately pending Agenda item and/or the matter under discussion will be considered at a time.
- Although everyone may ask up to two questions on the same matter, a question from a Member that has not yet posed a question will be given preference over a Member who has already asked a question.
- The Board will endeavour to answer as many questions as time permits, but may not be able to answer every question and may opt not to answer a question that they believe has already been asked and answered.
- No Members' proposals having been received by the Association in accordance with Section 81 of the Societies Act, only motions listed on the Agenda will be considered at the meeting.

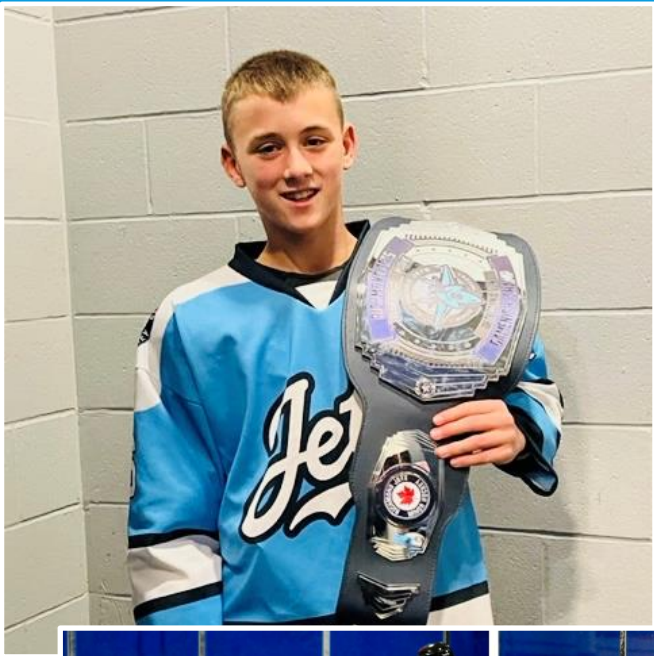

TREASURER'S REPORT

In 2022-2023, Richmond Jets are back to the normal operations before COVID-19. The season was full of challenges such as the humidifier fire during the Spring Classics tournament and on-going constructions at Richmond Ice Center. Thankfully, our parents, volunteers and the City staff were able to overcome these obstacles and allow our players to have a very successful season.

Overall, RJMHA has bounced back from our deficit to net profits of \$187,000. By the fiscal end of 2022-2023, RJMHA's cash position is at approximately \$387,000. With the net profits, RJMHA is able to keep the **registration fees unchanged** as previous year despite of the increased cost of operations.

This gain was due to the following:

- Significant increase in our tournament revenue
- Revenues in both Pre-season and In-season Opt-In programs
- Bank interest revenues
- Significant reduction in ice allocation than budgeted which resulted in reduction in ice rental costs
- Volunteer opt-in revenue – at the time of the report preparation, it is estimated that the revenue could be \$10,000. RJMHA strongly encourage our members to volunteer and it is not the association's intent to use this as part of the income streams.

Looking forward to the season of 2023-2024, we are optimistic that our registration will continue to grow. RJMHA is grateful to have the supports from all the parent volunteers and coaches throughout the season. Our volunteers have kept our cost low and affordable for our kids to enjoy the sports they love. Thank you!

1. DESCRIPTION OF BUSINESS

The Society is incorporated under the Society Act of British Columbia and was established on February 6, 2018 and commenced operations on April 1, 2018. The Society was formed by the merger of Richmond Minor Hockey Association with Seafair Minor Hockey Association for the purpose of strengthening the stewardship of hockey in the city of Richmond.

The Society is exempt from income taxes under the Income Tax Act of Canada.

2. BASIS OF ACCOUNTING

The basis of accounting applied in the preparation of the statement of financial position of Richmond Jets Minor Hockey Association as at March 31, 2023, and the statements of revenues and expenditures and changes in net assets for the year then ended is on the historical cost basis and reflects cash transactions with the addition of:

- inventory valued at cost

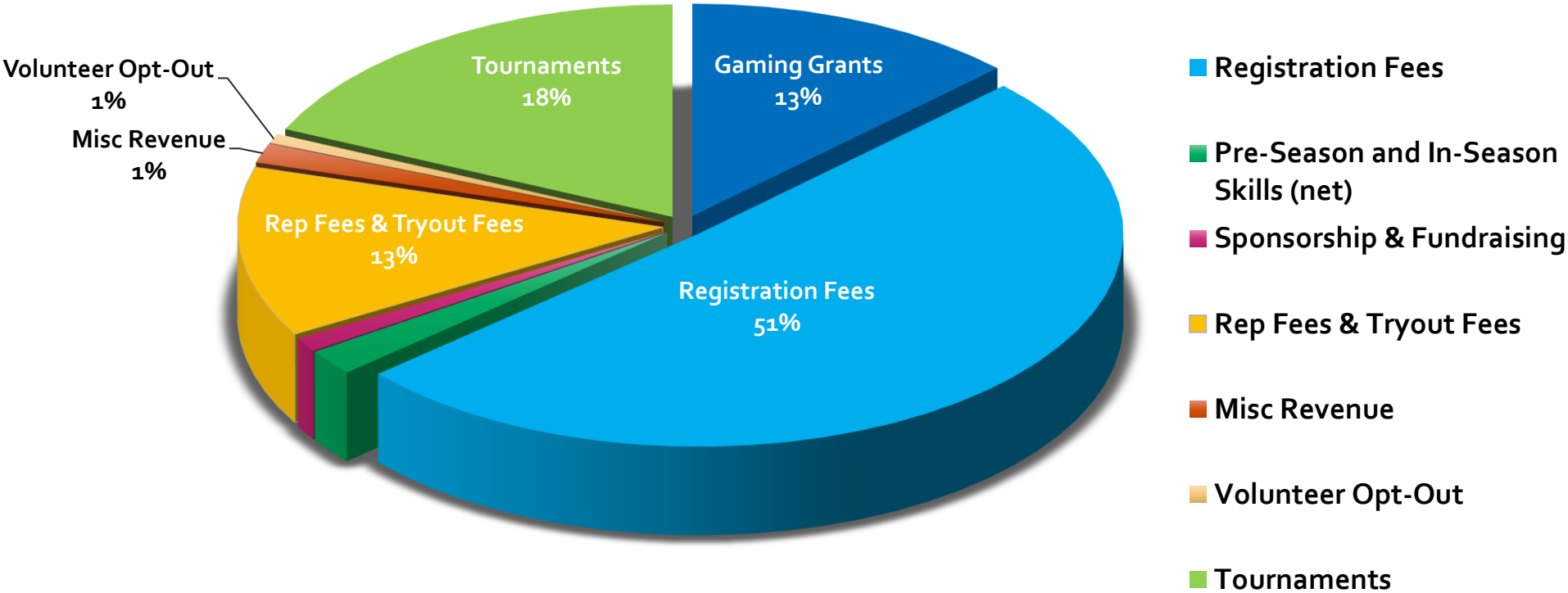

2023/2024 BUDGET - PROJECTED REVENUE



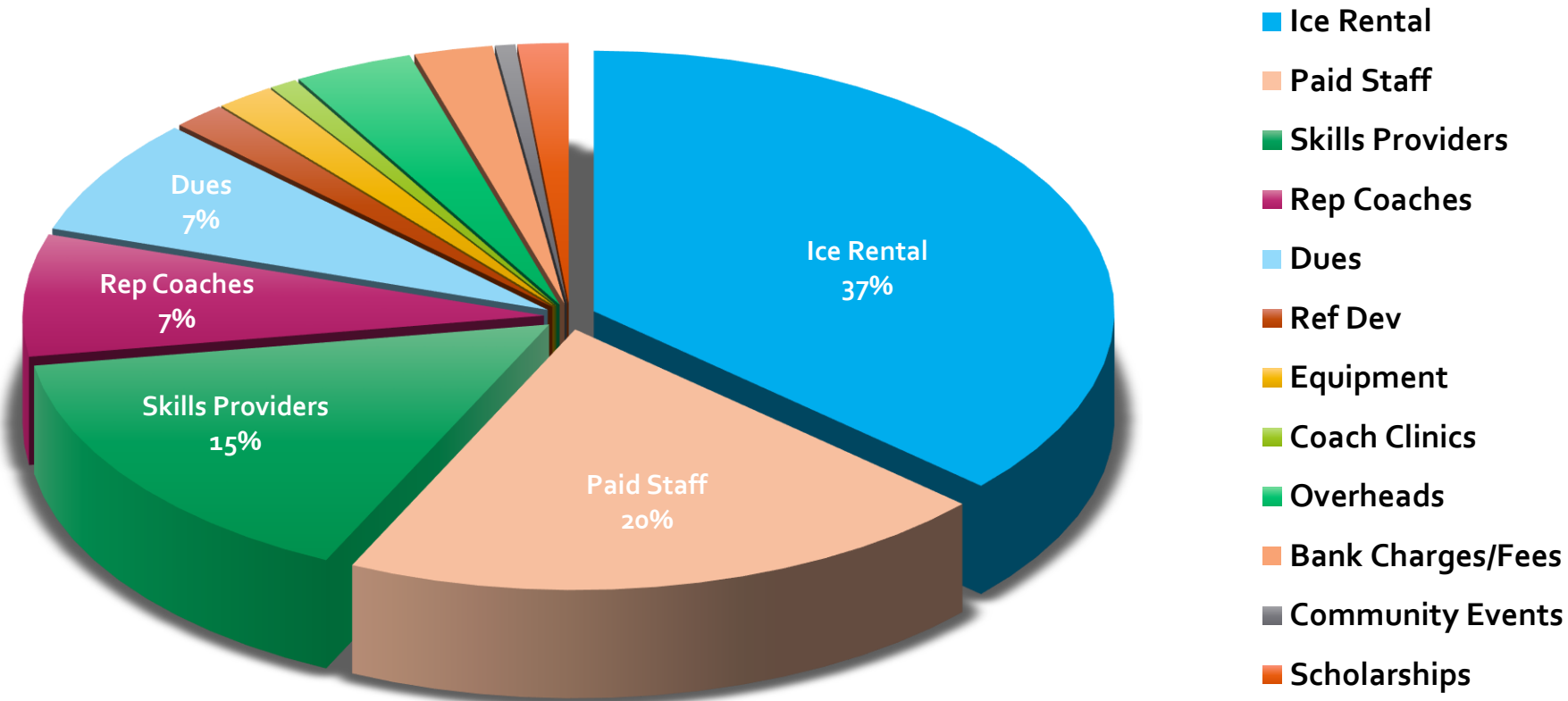

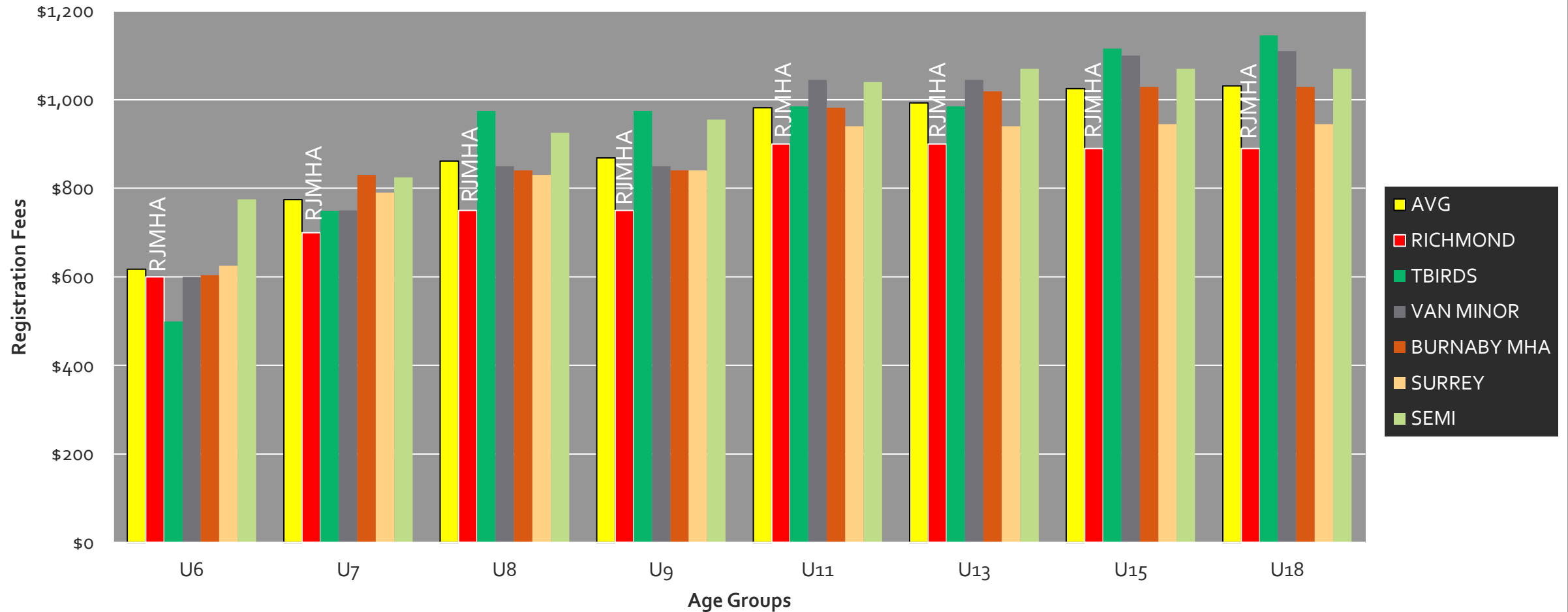

SPECIAL RESOLUTION TO AMEND THE RJMHA BYLAWS – 2023

The following special resolution to amend the RJMHA Bylaws were submitted May 2, 2023, in accordance with **Parts 21.2 and 21.3** of the RJMHA By-Laws. Amendments to the Bylaws require at least two-thirds (2/3) of the votes cast in respect of the resolution, by those members entitled to vote in accordance to Bylaws Part 1. INTERPRETATION, 1.1 Definitions.

#1. Bylaws of the Richmond Jets Minor Hockey Association

Submitted by: RJMHA Board of Directors

The Directors of the Richmond Jets Minor Hockey Association hereby notify the membership of the Society that the Board of Directors intend to submit a Special Resolution to a vote of the membership **pursuant to amend the Bylaws dated June 1st, 2021 03:53 PM Pacific Time**. The following Bylaws will be amended:

BYLAWS

Part 8 – DIRECTORS

- 8.3 Composition of Board
- 8.9 Appointment to fill Vacancy

Special Resolution:

Be it enacted and is hereby enacted as a special resolution of the Richmond Jets Minor Hockey Association that the **Bylaws Part 8.3 and 8.9 be amended**.

Currently as:

8.3 Composition of Board

The Board will be composed of a minimum of seven (7) and a maximum of eleven (11) Directors, Persons as set by Board Resolution.

Be amended to:

8.3 Composition of Board

The Board will be composed of a minimum of seven (7) and a maximum of eleven (11) Directors. **If there are vacancies (less than 11 directors) after the Annual General Meeting or to fill a vacancy if a director ceases to hold office of his or her term, then the Board can appoint up to two (2) Persons that are non-members as Directors in accordance with Bylaw 8.9.**

Currently as:

8.9 Appointment to fill Vacancy

If a Director ceases to hold office before the expiry of his or her term, the Board, by Board Resolution, may appoint a Person qualified in accordance with Bylaw 8.2 to fill the resulting vacancy.

The position occupied by an appointed replacement Director will become available for election at the next annual general meeting and each such appointed replacement Director will continue in office until the conclusion of the next annual general meeting unless he or she otherwise ceases to be a Director in accordance with these Bylaws. The appointed replacement Director may run for the vacant position. The Board will be composed of a minimum of seven (7) and a maximum of eleven (11) Directors, Persons as set by Board Resolution.

Be amended to:

8.9 Appointment to fill Vacancy

If a Director ceases to hold office before the expiry of his or her term, the Board, by Board Resolution, may appoint a Person qualified in accordance with Bylaw 8.2 to fill the resulting vacancy.

The position occupied by an appointed replacement Director will become available for election at the next annual general meeting and each such appointed replacement Director will continue in office until the conclusion of the next annual general meeting unless he or she otherwise ceases to be a Director in accordance with these Bylaws. The appointed replacement Director may run for the vacant position. The Board will be composed of a minimum of seven (7) and a maximum of eleven (11) Directors, Persons as set by Board Resolution.

The Board may, from time to time by Board Resolution, appoint as a Director up to two (2) qualified Persons to bring the total number of directors to a maximum of 11, who have expertise, skills or knowledge that is beneficial to the Board or to the Association (as determined by the Board) and such Directors need not be Members. Directors appointed by the Board will take on the duties of a Director in accordance to Part 10 - POWERS AND RESPONSIBILITIES OF THE BOARD, and will be entitled to vote in accordance to Part 12.3

- Entitlement to Vote

Discussion:

The purpose of this amendment is for the RJMHA Board to have a maximum of eleven (11) directors as per the Bylaws, as decided by Board resolution.

9.1 Nomination of Directors

Nominations for election as a Director must be made in accordance with the Bylaws, and such policies and procedures as are established by the Board from time to time. All nominations are subject to the following rules:

- (a) a nomination must be made in writing, in a form established by the Association;
- (b) a nominee must be a Member in good standing to be nominated and must remain in good standing in order to stand for election;
- (c) a Member may nominate him or herself, and the nomination must be signed by the Member nominated and one (1) other Member in good standing;
- (d) a Member may not nominate more nominees than the number of Director positions available for election;
- (e) nominations must be submitted in advance of an election, in accordance with such deadlines as may be established by the Board; and
- (f) nominations will not be permitted from the floor at a General Meeting.

7.4 Voting Methods

Voting by Members may occur by any one or more of the following methods, in the discretion of the Board:

- a) by show of hands or voting cards;
- b) by written ballot; or
- c) **by vote conducted by Electronic Means.**

ElectionBuddy is an online voting platform that provides secure and reliable solutions for conducting elections, particularly for organizations, businesses, associations, and other groups that require a robust and trusted voting system.

Voting Procedures:

- All ordinary members in good standing, 19 years of age or older (player U21, parent of a player), based on emails provided at registration for the 2022-23 season, head coaches and assistant coaches who do not have a child in the association and life members, will be sent an email on the voting procedures on Friday June 2nd and voting will open at 6PM on June 2nd and run until Monday June 5th at 9PM.
- At that time, the system will tally the votes and provide the results to Eric Bernal – President and Wayne Carleton - Executive Director.
- The results will be communicated to the members via email and posted on our website and social media platforms.
- In the event there is a tie a second vote will be required, which will be communicated to the members.
