Annual General Meeting Minutes 2026

1. **Welcome and call to order, 7:03pm** – Trent Gustafson
2. **Introduction and opening remarks by AGM Chair** – Trent Gustafson
3. **Establish quorum and review meeting rules** – Quorum established at 7:03PM – **27 members in attendance. Total of 35 in attendance at 7:20PM.**
4. **Review Agenda** – Agenda reviewed, no addition to the agenda.

5. **Approval of 2025 AGM Minutes:**

6. **Annual Reports:** (refer to all reports on the RJMHA website)
 1. **Volunteer Recognition:** Volunteer Recognition was presented by Trent Gustafson & Wayne Carleton – Executive Director. Trent also reviewed our PCAHA Banner winners for the 2025-2026 season.
 2. **Scholarships:** RJMHA Graduating Scholarships, and PCAHA scholarships were presented by Trent Gustafson. There were 12 recipients this year and 1 PCAHA scholarship awarded. Trent Gustafson also discussed the U18 Grad Game & Events.
 3. **Finance Committee: Presented by Hanif Hamir RJMHA Treasurer**
 - Presentation of Finance and Audit committee report and Financial Statements for year ending March 31, 2026.
 - The 2025-2026 season was another successful year for the Richmond Jets Minor Hockey Association (RJMHA). The association continues to put forth a program with great value for its members.
 - Overall, we finished the season with an excess of revenue over expenses of a little over \$24K. With increased cost pressures, RJMHA was able to achieve this without raising registration fees for members.

- Some highlights include the following:
 - REVENUES:**
 - Registration & fees – up 1.6%. Pre-season & in-season skills camps continue to do well
 - Tournaments – down 4%.
 - Volunteer opt out fees – up 16%.
 - EXPENSES:**
 - Ice Rental – on par with prior year.
 - Tournament costs - down 9.2%. Primarily due to reducing operating costs.
 - Hockey Fees – up 10.1%. Fees from both PCAHA and BC Hockey are rising.
 - Advertising & Promotion – up 99.5%. Primarily due to larger social events (Canada Day, Opening Day, Grad Skate)
 - In addition to the operations for the season, RJMHA purchased shared video cameras for all Rep Teams.
 - For the 2026-2027 season, we will be implementing a \$40 increase to registration fees. This will help offset additional increases in ice rental, PCAHA fees and inflationary
 - Hanif reviewed the operating budget for 2026-27, using pie charts for revenues and expenses. We are projecting a break-even budget this year. Hanif also reviewed registration fees, showed comparison chart and the cost per sessions for U13C and U18C players. Jets still have the lowest fees in the PCAHA compared to other Vancouver area associations, even with a slight increase of \$40.00.

7. Election of Directors for 2026 - 2028:

- Executive Director, Wayne Carleton reviewed the nomination process, and the retiring and returning directors:
 - Retiring directors **Madeleine Lau and Adam Blanchette** were recognized and thanked for their service.
 - Returning directors include: **Trent Gustafson, Hanif Hamir, Mark Rustia, Julie Bauer, Randy Sandhu and Gonzalo Del Castillo.**
- The candidates for Director positions were presented, and the following nominations (6) were confirmed prior to the AGM per the RJMHA bylaws – **Charmaine Schmaltz and Henry Han** were seeking re-election and there were 4 new candidates, **Allan Scott, Colin Wong, Marco Tan and Teresa Huang.**
- The election process was reviewed by Wayne Carleton, and the election will take place from June 3rd to June 7th by the online platform – **Election Buddy** for the 5 director positions. Results will be made available in the week of June 8th
